

BIO: Born in Northeast Ohio and raised in Greater Columbus, Trent Vogelhuber was announced by the Columbus Blue Jackets as the seventh head coach in Monsters history on June 8, 2022. The 2025-26 season marks Vogelhuber's fourth year at the helm for the Monsters following four seasons as a Cleveland assistant coach from 2018-22.

Originally selected by Columbus in the seventh round (211th overall) of the 2007 NHL Entry Draft, Vogelhuber posted 28-45-73 with 191 penalty minutes and a +8 rating in 267 AHL appearances for the Springfield Falcons, Lake Erie Monsters, and San Antonio Rampage spanning parts of seven seasons from 2011-18 and helped the Monsters claim the 2016 Calder Cup as AHL Playoff Champions. A right-shooting forward, Vogelhuber added 6-10-16 with 20 penalty minutes and a +3 rating in 34 ECHL appearances for the Evansville IceMen in 2012-13.

Prior to his professional career, Vogelhuber registered 21-30-51 with 123 penalty minutes and a +17 rating in 149 NCAA appearances for Miami University spanning four seasons from 2008-12 and helped the RedHawks claim the 2009-10 CCHA Regular Season and 2010-11 CCHA Tournament Championships. He also posted 0-1-1 with a -2 rating in two USHL appearances for the Des Moines Buccaneers in 2007-08

MONSTERS COACHING STAFF

Chris Bergeron, Associate Coach

A former centerman and native of Wallaceburg, ON, Bergeron, 55, spent five seasons as Miami (OH) University's Head Coach (2019-24) following a nine-year stint as Head Coach at Bowling Green State University from 2010-19. Bergeron began his coaching career with a decade spent as an Assistant Coach at Miami from 2000-10, during which time he overlapped with Monsters Head Coach Trent Vogelhuber from 2008-10 during Vogelhuber's collegiate playing career. Bergeron played college hockey at Miami from 1989-93, served as Miami's captain from 1991-93, and enjoyed a seven-year professional playing career in the IHL, ECHL, CHL, UHL, and AHL from 1993-2000. 2024-25 marks Bergeron's second season with the Monsters as Associate Coach.

Stefan Matteau, Assistant Coach

A Chicago native, Matteau, 31, enjoyed a 92-game NHL playing career spread across parts of eight seasons from 2012-13, 2014-16, 2017-18, and 2019-22 with the New Jersey Devils, Montreal Canadiens, Vegas Golden Knights, and Columbus. In 411 career AHL appearances for the Albany Devils, St. John's IceCaps, Chicago Wolves, Colorado Eagles, and Cleveland spanning parts of ten seasons from 2013-20, Matteau logged 76-93-169 with 477 penalty minutes. The 29th overall pick in the 2012 NHL Draft, Matteau retired in August 2025 at the conclusion of a 13-season pro career and immediately transitioned from Cleveland's capitain to the club's newest assistant coach.

MONSTERS NOTES

NEW ACQUISITION: Columbus reassigned C **Danton Heinen** to Cleveland on Monday after Heinen's acquisition alongside a pair of draft picks by Columbus from Pittsburgh via trade in exchange for RW Yegor Chinakhov. In 13 NHL appearances for Pittsburgh this year, Heinen posted 1-1-2 with eight penalty minutes and a +1 rating and added 6-11-17 with six penalty minutes and a +10 rating in 12 AHL appearances for Wilkes-Barre/Scranton.

HOME, SWEET HOME: The Monsters currently lead the AHL in average attendance (11,341) and are riding a five-game home point streak (4-0-1-0), tied for the AHL's second-longest such active streak.

INJURY REPORT: Cleveland LW **Ryland Mosley** and C **Max McCue** are week-to-week with upper-body injuries with Mosley out for 20 straight games and McCue out for 19 while Monsters D **Will MacKinnon** is day-to-day with an upper-body injury.

FANTASTIC FEDOTOV: Cleveland G **Ivan Fedotov** currently ranks among the AHL's leaders in minutes played (1075:15, 5th) and goals-against average (2.46, 11th).

GOING STREAKING: Cleveland C **Luca Del Bel Belluz** is riding a three-game point streak (1-4-5) while LW **Mikael Pyyhtia** is riding a three-game point streak (3-4-7) and a three-game assist streak (4).

EXTRA TIME: Cleveland ranks among the AHL's leading clubs this season in overtime appearances (10, T4th), overtime wins (5, T1st), and overtime points (15, 4th).

TEDDY BEAR TIME: On December 20th, Cleveland hosted the club's annual Teddy Bear Toss, during which the seventh-largest crowd in Monsters history and the largest for the club since 2019 (16,248) heaved a team-record 30,124 plush toys onto the ice to donate to local charities across Northeast Ohio this Holiday season. Leading scorer LW **Luca Pinelli** provided the Monsters' first goal at 15:26 of the opening frame to trigger the torrent of Teddies.
